## RISK PROFILE

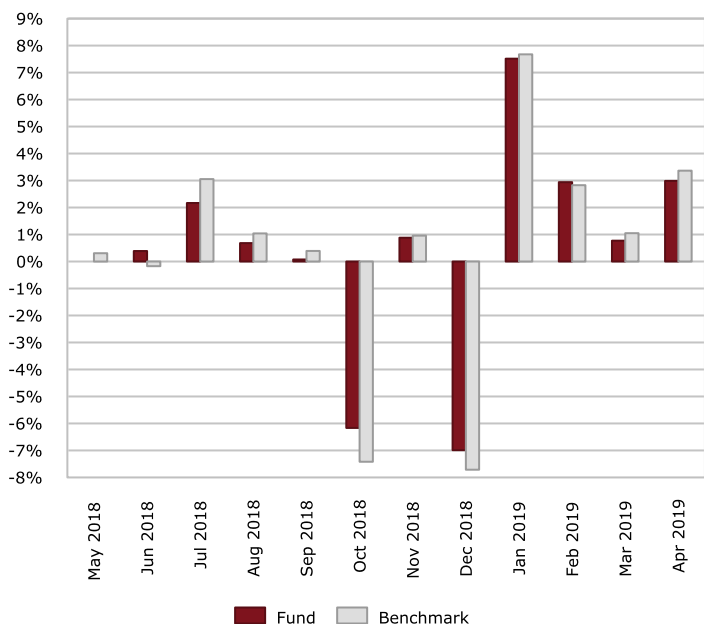

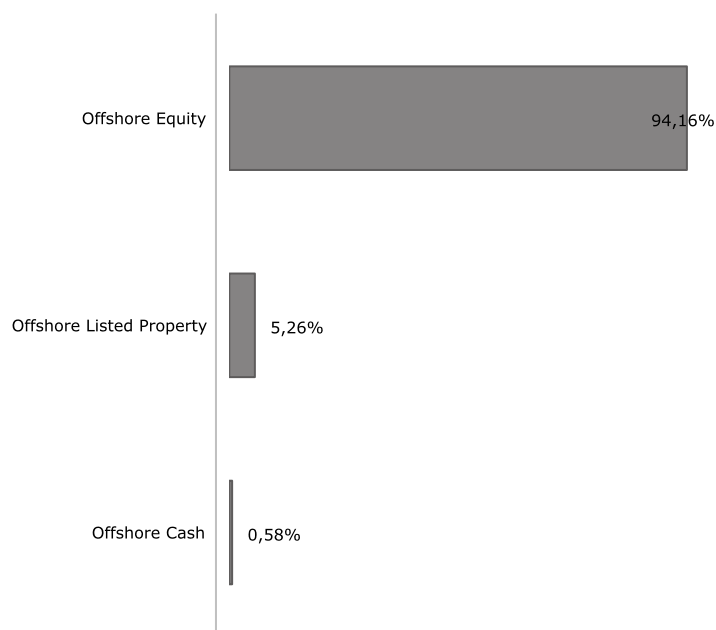
## FUND DESCRIPTION
